

DEFINING "MIGRANTS"

IOM defines as a migrant any person who moves away from his or her place of usual residence, whether within a country or across an international border, temporarily or permanently, and for a variety of reasons







DEFINING "MIGRANTS"

8 billion people: 1 in 8 is a migrant





More than half are women and girls


13% of international migrants are children (36 million).

Number of people forcibly displaced: 117.3 million.

Number of new displacements triggered by disasters in 2023: 46.9 million

In 151 countries and territories

Estimated number in irregular situations: 15-20%.







MIGRATION & 2030 AGENDA

The 2030 Agenda provides a key opportunity to proactively address migration and its relationship to development.

The SDGs and the Global Compact for Migration (GCM) share the same vision for orderly, safe and regular migration – referenced under SDG target 10.7.





MIGRATION & DEVELOPMENT

Some key figures:

- Every 1% increase in immigration can boost GDP growth in destination countries by 2%.
- By 2030, migrants will contribute an estimated USD 500 billion to OECD economies.
- Global Remittance Flow (2024): \$905 billion USD Belgium's Remittance Flow: Over \$7 billion USD
- Remittances to Low and Middle-Income Countries: Equivalent to nearly 6% and 2% of GDP





ACHIEVING THE 2030 AGENDA



Global frameworks (GCM) recognize migrant rights, but inconsistent integration into peace, climate, and development policies hinders human mobility's contribution to global solutions.



Negative public perception and dehumanization of migrants, especially in political discourse, hinder effective migration management and societal cohesion.

Without due consideration of migration and of migrants, the 2030 Agenda will not be achieved.
